

Conference ends 2015-16 with a deficit

Ohio Conference ended its 2015-16 fiscal year March 31 with an operating balance of -\$65,209. The Conference operating deficit was reduced slightly during March.



Receipts for the month of March totaled \$41,194, while expenses for the month were \$34,714.

Total receipts for 2015-16 were \$371,097, a decrease from the \$425,337 received in 2014-15. Total expenses for the year were \$436,386, which is less than the amount of spending called for in the 2015-16 spending plan, \$526,170.
